He has a degree in Social Sciences from USP, a master's degree in Political Science from the same university, and a double PhD in Political Science from USP and the École des Hautes Études en Sciences Sociales (EHESS). He was a postdoctoral researcher in the Department of Philosophy at the Federal University of São Carlos (UFSCar), with a research internship at Centre d'Études Sociologiques et Politiques Raymond Aron at École des Hautes Études en Sciences Sociales (CESPRA-EHESS), where he was an associate researcher from 2020 to 2022. He works in the intersection of the history of political thought and contemporary political theory, having studied French political liberalism in the first half of the 19th century, and reflections on totalitarianism, liberalism, democracy and human rights in contemporary French political thought. He is currently developing a research project on the revival of political realism in contemporary political theory, its historical antecedents, and its contributions to thinking about the issues of “Global Justice”.
