Objetivo

O curso tem por objetivo apresentar os principais temas de estudos de Análise de Política Externa (APE), caracterizado tanto por uma bibliografia consolidada na área, quanto por textos recentes e agendas emergentes. Distintas abordagens ontológicas e epistemológicas serão estudadas, com forte ênfase ao desenho de pesquisa e métodos abordados na literatura especializada. Do ponto de vista empírico, diversos casos são analisados como Brasil, Argentina, Estados Unidos, África do Sul, China, Libéria, Suécia, Reino Unido, Egito, Nigéria, Venezuela, Ruanda, entre outros. Estudos comparados também são explorados no curso.
